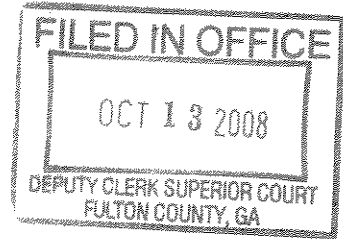

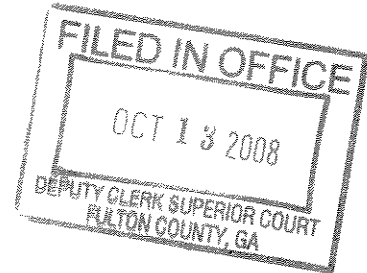



ORDER

record to the Georgia Supreme Court as soon as possible, but in any event, no later than Friday, October 17, 2008.
