**STIPULATION AND ORDER FOR EXTENSION OF TIME FOR PLAINTIFFS TO  
MOVE FOR ATTORNEYS' FEES AND COSTS**

On April 4, 2008, this Court entered Judgment in this matter. In the interest of preserving the time and resources of the Court and of the parties, the parties, by and through counsel, have conferred and stipulate that:

Plaintiffs shall have until twenty-eight (28) days after the conclusion of all appeals in this case to file their motion for attorneys' fees and costs, including taxable costs.

"The conclusion of all appeals" means the latest of: (1) the expiration of Defendant's time to file a notice of appeal with the United States Court of Appeals for the Sixth Circuit; (2) if Defendant appeals to the United States Court of Appeals for the Sixth Circuit, the expiration of time to file a petition for certiorari to the United States Supreme Court following a final decision by the Sixth Circuit; (3) the denial of a petition of certiorari by the United States Supreme Court; or (4) the granting of a petition for certiorari and disposition of this case by the United States Supreme Court.

Rather than file a separate Bill of Costs, Plaintiffs shall include the taxable items with the other costs for which they seek an award on the schedule established in this Stipulation and Order.

Defendant does not waive any objections, defenses or arguments as to any motions, bills or requests for attorneys' fees or taxable costs.
