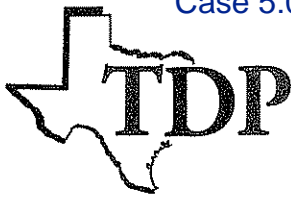

The Texas Democratic Party has learned that your organization is planning to file a lawsuit challenging the 2008 Texas Democratic Primary process. If this is true, we request that the Texas Democratic Party be provided details concerning the factual complaints that would form the basis of such a lawsuit.

As you know, the Texas Democratic Party rules, in effect this cycle, were adopted in the late 1980s. The rules have been in use for several cycles. No challenge was made to the rules prior to actual voting. As you know, the law looks unfavorably on challenges to election procedures that occur after voting ends.

Having said that, the Texas Democratic Party is focused on presenting the cleanest, fairest, general election possible given the unprecedented turnout. Because the delegate selection process continues over time, the Texas Democratic Party is working out procedures to deal with the complaints we have received regarding the Precinct Conventions. The next step in the process are County and Senate District Conventions that will convene on March 29, 2008. The Texas Democratic Party is prepared to deal with the concerns raised during Tuesday's conventions in a fair and efficient manner within the rules of the Texas Democratic Party as well as State and Federal law.


The Texas Democratic Party is interested in meeting with you and hearing the concerns of your organization so that they can be considered by the procedures adopted for use at the upcoming conventions.
