PLAINTIFFS' NOTICE OF PENDING, REFILED, RELATED OR SIMILAR ACTIONS

Plaintiffs League of Women Voters of Florida, Florida AFL-CIO, American Federation of State, County, and Municipal Employees, Council 79 ("AFSCME"), and Marilyn Wills, files this Notice pursuant to S.D. Fla. L.R. 3.8.

Plaintiffs notify the Court that the plaintiffs in this action, seeking to enjoin 2007 Fla. Laws 30 §§ 1, 2, brought an action, along with other organizational plaintiffs, to enjoin its predecessor law, 2005 Fla. Laws 277 §§ 2, 7. This Court preliminarily enjoined the predecessor law on August 28, 2006 in an action entitled *League of Women Voters of Florida, et al. v. Cobb* ("*LWVF*"), Civil Action No. 06-21265 before the Honorable Patricia A. Seitz of this Court.

LWVF was dismissed four days ago on April 24, 2008. This action raises nearly identical issues as *LWVF*, all the plaintiffs in this action were plaintiffs in *LWVF*, and the defendants in both actions are identical—except to the extent that individuals sued in their official capacities in *LWVF* may have been replaced in their offices by defendants in this action.
