CONSENT ORDER

All parties in the above-entitled action come now before the Court to jointly move that all proceedings be immediately stayed, pending an order in the consolidated appeals of Weinschenk v. State of Missouri, No. 06AC-CC00656 (Cole County Cir. Ct. 2006), and Jackson County v. State of Missouri, No. 06AC-CC00587 (Cole County Cir. Ct. 2006), presently scheduled to be heard before the Missouri Supreme Court on October 4, 2006.

The parties agree that they have no desire to needlessly consume judicial resources in this matter, if the legal status of the statute at issue in this matter may be fully resolved by the Missouri Supreme Court. Therefore, in the interests of judicial economy, the parties respectfully request that this matter be stayed pending the Missouri Supreme Court's ruling, after which further proceedings, including briefing and hearing on plaintiffs' Motion for Preliminary Injunction, *inter alia*, may proceed, if appropriate in light of the Missouri Supreme Court's ruling.
