**SECOND MOTION TO COMPEL OF MILTON MCGREGOR**

COMES NOW McGregor and moves this Court to compel the Government to produce the final transcripts of consensual recordings and wiretapped recordings that it intends to use at trial. As grounds for the same, McGregor shows the following:

(1) McGregor moved to compel the transcripts in its Motion to Compel filed January 6, 2011. (*See* Doc. 325).

(2) On January 26, 2011, this Court ordered that the transcripts requested be produced, saying specifically: “that the Government shall provide finalized transcripts to Defendant as quickly as possible.” (*See* Doc. 373)

(3) Thus far, notwithstanding at least two written requests for the same by McGregor’s counsel to the Government during the week of February 14, 2011, the Government has not produced such final transcripts.

Based on the foregoing, McGregor asks the Court to order the Government to provide to its counsel all of the finalized transcripts it intends to use at trial on a date certain.
