6. I am registered to vote in Cuyahoga County, Ohio, and my registration uses this address: 1710 Prospect #333 Cleveland
7. I am currently, and have been since on or before October 18, 2006, a member of the Northeast Ohio Coalition for the Homeless.
8. I voted in the November 2006 election.
9. If able to do so, I intend to vote in the November 2008 general election and the elections that follow. My right to vote and to have my vote be counted is important to me. I believe that it is one of my civic responsibilities to vote and I take this obligation very seriously.
10. I understand that when I vote on Election Day I will be required to present identification to verify my identity. 
Trina Morgan (name) respectfully states as follows:
