1 I, Lisa K. Oldham, hereby declare as follows:

2 1. I am over 18 years old, a United States citizen, and a resident of the state of
3 Washington. I have lived at my current address, 3011 NE 140th Avenue, Vancouver,
4 Washington 98682 since November 2003.

5 2. On February 18, 2006, I attempted to register to vote by filling out a voter
6 registration form, which I completed and submitted by mail. I wrote down my name,
7 address, date of birth, telephone number, and my Washington driver's license number on the
8 form. Though it was not required, I also wrote down the last four digits of my Social
9 Security number. The information I wrote down is accurate. A copy the registration form I
10 filled out is attached as Exhibit A.

11 3. My married name is "Graham," and my driver's license is in my married
12 name, "Graham" (the number is "GRAHALK328NG"), but my Social Security card is in my
13 maiden name, which is Oldham.

14 4. In March or April, after I submitted my registration form, I received a written
15 notice saying that there was a problem with my registration because the last name I used on
16 my application, Oldham (my maiden name), is not the same as the last name on my driver's
17 license (my married name).

18 5. I was upset to find out that even though the government knows that I am a
19 real person and that Oldham is simply my maiden name, it would not let me register to vote
20 under my legal last name. I had planned to vote in the May 16, 2006 special election but did
21 not try to do so because I knew I was not registered and would not be able to vote.

23 I declare under penalty of perjury under the laws of the state of Washington that the
24 foregoing is true and correct and of my own knowledge.


