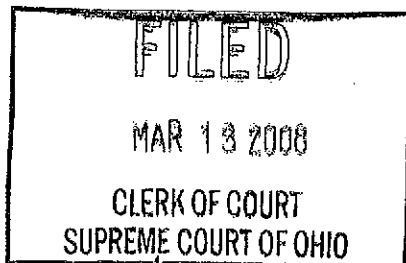



**SUPPLEMENT TO MOTION TO REQUIRE RELATOR TO FILE VIDEOTAPED
DEPOSITION UNDER SEAL ON BEHALF OF OHIO SECRETARY OF STATE
JENNIFER BRUNNER**

Prior to her deposition, Ohio Secretary of State Jennifer Brunner filed a motion with this Court asking it to require the Relator to file her videotaped deposition under seal and to prohibit any copies of that videotape from being made. At some point during the deposition, Mr. Alex Arshinkoff asked the videographer to provide him with three copies of the videotaped deposition. There is no reason that counsel for Relator, much less Mr. Arshinkoff, actually needs a single copy of the videotaped deposition in order to litigate this case. The question of why Mr. Arshinkoff needs three copies of the videotape is even more baffling. Therefore, Secretary of State Brunner asks this Court to issue an order requiring the original videotape of her deposition to be filed under seal and for this Court to order that any copies of that tape that may have already been made to be accounted for by the Relator and to be filed with this Court under seal.


