**DEFENDANT WALKER'S RESPONSE TO THE
GOVERNMENT'S CONSOLIDATED MOTION (Doc. 1697)**

Now comes Jarrell W. Walker, Jr., by counsel, and in response to the Government's Consolidated Motion (Doc. 1697), submits the following:

I. Severance

Mr. Walker opposes the motion of the Government to sever the defendants for trial. Mr. Walker agrees with the position and argument of Defendant McGregor in his opposition to severance filed on August 22, 2011 (Doc. 1724).

II. Continuance
