Defendant Millic Santillanes, by and through her undersigned attorneys, states the following for its notice of completion of briefing for defendant's motion for summary judgment:


1. On September 13, 2006, defendant filed its motion for summary judgment and memorandum. Dkt. Nos. 63 and 64
