Defendants and their officers, agents, employees, and successors in office, and all people in active concert or participation with them, are hereby permanently enjoined from enforcing Article 6 § 3 of the Washington State Constitution and the statute implementing it, or otherwise preventing people with felony convictions from registering to vote and voting on the basis of their felony convictions.
