**MOTION TO WITHDRAW AS MOOT CONTINGENT MOTION TO
TRANSFER**

Plaintiffs-Appellants Arcia, *et al.* (“Plaintiffs”) hereby request that their Contingent Motion to Transfer Consideration of Attorneys’ Fees on Appeal to the District Court be withdrawn as moot.

1. On May 5, 2014, Plaintiffs filed an unopposed motion for an extension of time to file a fee petition.
2. On May 6, 2014, because the Court had not yet ruled on Plaintiffs’ motion, Plaintiffs filed a contingent motion for this Court to transfer consideration of attorneys’ fees on appeal to the district court in the event that it did not grant Plaintiffs’ May 5 motion.
3. On May 12, 2014, this Court granted Plaintiffs’ May 5 motion.
4. Because the Court granted Plaintiffs’ May 5 motion, Plaintiffs’ contingent motion is therefore moot.
