DOCKETING STATEMENT

Plaintiffs in the above captioned matter, by undersigned counsel, file this Docketing Statement pursuant to 7th Cir. R. 3(c)(1), and 28(a), simultaneously with Plaintiffs' Notice of Appeal.

1. The United States District Court had jurisdiction pursuant to 28 U.S.C. §§ 1331, 1343(a)(3)-(4) and 52 U.S.C. § 10101(d), over this action brought pursuant to 42 U.S.C. § 1983 for alleged violations of the Fourteenth and Twenty-Fourth Amendments to the United States Constitution and Section 2 of the Voting Rights Act of 1965, 52 U.S.C. § 10301. Plaintiffs are natural persons and United States citizens, and no party is a private corporation.

2. The United States Court of Appeals for the Seventh Circuit has jurisdiction pursuant to 28 U.S.C. § 1291 over this direct appeal of the district court's October 19, 2015 Decision and Order (Dkt. #250) and November 5, 2015 Judgment (Dkt. #253) dismissing Plaintiffs' remaining claims. Plaintiffs timely filed a notice of appeal on this date, November 17, 2015, within 30 days after the November 5, 2015 Judgment. Fed. R. App. P. 4(a)(1)(A).

3. There are no claims that remain for disposition in the district court.

4. There was a prior appellate proceeding in this case, captioned *Ruthelle Frank, et al. v. Scott Walker, in his official capacity as Governor of State of Wisconsin, et al.*, Docket Number 14-2058 (7th Cir.).

5. The Defendants are sued in their official capacities. To the best of Plaintiffs' knowledge, the current occupants of the respective offices are as follows:¹
