EXTEND THE STAY OF, OR RECALL AND STAY, THE MANDATE  
THROUGH THE CONCLUSION OF THE APRIL 7, 2015, ELECTIONS**

Following the U.S. Supreme Court's March 23, 2015, denial of a petition for a writ of certiorari in this case, Wisconsin Attorney General Brad Schimel stated publicly that the voter photo identification requirement cannot be enforced for April 7, 2015, elections because absentee ballots are already in the hands of some voters. *See* Press release, March 23, 2015, [http://www.thewheelerreport.com/wheeler\\_docs/files/0323schimel.pdf](http://www.thewheelerreport.com/wheeler_docs/files/0323schimel.pdf). As a result, Defendants-Appellants do not oppose Plaintiffs-Appellees' emergency motion. If the Court grants Plaintiffs-Appellees' motion, the mandate should issue on April 8, 2015. *See* Fed. R. App. P. 41(d)(2)(D).

Accordingly, this Court should issue its mandate on April 8, 2015.
