- 1 moves to amend the bill on page 2, lines 38-41, by rewriting those lines to read:
- 2        "(7) A drivers license or nonoperators identification card issued by another state,
- 3        the District of Columbia, or a territory or commonwealth of the United
- 4        States.";
- 5
- 6 and on page 2, lines 41-42, by inserting the following between those lines:
- 7        "(8) An identification card issued by any accredited public or private college
- 8        university, or community college located in North Carolina.";
- 9
- 10 and on page 1, line 21, by rewriting that line to read:
- 11 "G.S. 163-82.6A, G.S. 163-227.2, or G.S. 163-182.1A shall present photo identification
- 12 bearing any reasonable";
- 13
- 14 and on page 4, lines 8 and 9, by inserting the following between those lines:
- 15        "**SECTION 2.4.** G.S. 163-82.6A(b) reads as rewritten:
- 16        "(b) Both Attestation and Proof of Residence Required. – To vote under this section, a
- 17 voter shall present photo identification in accordance with G.S. 163-166.13. This requirement is
- 18 separate from the requirement to provide proof of residence under s subdivision (2) of this
- 19 subsection. To register and vote under this section, the person shall do both of the following:
- 20        (1) Complete a voter registration form as prescribed in G.S. 163-82.4, including
- 21        the attestation requirement of G.S. 163-82.4(b) that the person meets each
- 22        eligibility requirement. Such attestation is signed under penalty of a Class I
- 23        felony under G.S. 163-275(13); and
- 24        (2) Provide proof of residence by presenting any of the following valid
- 25        documents that show the person 's current name and c urrent residence
- 26        address: a North Carolina drivers license, a photo identification from a
- 27        government agency, or any of the documents listed in G.S. 163-166.12(a)(2).
- 28        The State Board of Elections may designate additional documents or
- 29        methods that suffice and shall prescribe procedures for establishing proof of
- 30        residence."";
