**SECOND STIPULATION REGARDING INFORMATION IN THE SEIMS DATABASE:
PUBLICALLY AVAILABLE INFORMATION ACCESSIBLE THROUGH THE NORTH
CAROLINA PUBLIC VOTER INFORMATION WEBSITE**

The United States and Defendants stipulate to the authenticity and admissibility of the information contained in the attachment to this stipulation to the extent that it details voting information concerning witnesses whose testimony will be included in the record of this case, and that the attachment accurately reflects and details information from the SEIMS database¹ accessible through the North Carolina Public Voter Information website² as of May 29, 2015, with respect to registered voters identified by the United States as having discoverable information related to the effect of HB 589 on their right to vote.

¹ “SEIMS” is the acronym for the State Elections Information Management System, the computer system used by North Carolina to manage elections. The system was created following a law passed by the General Assembly in 1994 to implement a statewide computerized elections management system to support the work of the state and county election boards.

² The North Carolina Public Voter Information website is a publicly available resource maintained by the North Carolina State Board of Elections. The website includes a search tool that allows users to access the name, address, voter registration number, race, polling place, voter history, and other basic voting-related information for all registered voters in North Carolina. It can be accessed at https://www.ncsbe.gov/webapps/voter_search/.
