Getting a free ID for voting is easy

- 1) Visit your local DMV office
We'll help. To find a DMV, call us
(608) 266-1069
- 2) Bring the following, if available:
 - **Proof of name and date of birth**
(such as a Birth Certificate)
 - **Proof of identity**
(Social Security Card, Medicaid/Medicare card, etc.)
 - **Wisconsin residency**
(Utility Bill, Government Mail, Lease, etc.)
 - **Proof of U.S. citizenship**
(U.S. Birth certificate or Citizenship paperwork)
 - **Social Security Number**
- 3) If you don't have all or any of these...
you can still get an ID for voting. Just bring what you have to the DMV, fill out two forms, **and you will get a photo ID document in the mail that you can use in time for voting.**

You will soon receive an ID for voting!

In about a week, you will receive either a Wisconsin ID card or a paper receipt in the mail.

Either one can be used as ID to vote.

If you apply the week before the election or the week of the election (October 31st through November 10th), paper receipts will be sent via overnight mail, so you will receive it the day after you apply.

A Wisconsin ID looks like a driver's license. The paper receipt looks like this:

Getting a free ID for Voting is easy even if you do not have the documentation to get a regular Wisconsin ID!

1. Go to the DMV to apply
2. Bring whatever you have of the following:
 - **Proof of Name and Date of Birth** (Birth Certificate, Passport)
 - **Identity** (Social Security Card, Medicaid/Medicare Card, ID card from another state, etc.)
 - **Wisconsin Residency** (Utility bill, government mail, lease, etc.)
 - **Proof of U.S. Citizenship** (U.S. Birth certificate or citizenship paperwork)
 - **Social Security Number**
3. Even if you do not have all or any of those documents, you will receive a Wisconsin ID or a paper receipt in the mail in time for voting. Either one can be used as ID to vote.

If you already hold an unexpired Wisconsin driver license or identification (ID) card, or if you hold a Wisconsin driver license or identification (ID) card that has expired since the last general election (currently November 4, 2014), you have what you need to vote. A Wisconsin driver license or ID card is acceptable photo ID for voting.

DMV does not have information regarding voter eligibility, poll locations, voter registration information or other election information. Please contact your local election officials or county clerk for election information. The Wisconsin Elections Commission is another useful source of information.
