SCHEDULING ORDER II

AND NOW, this 20th day of September, 2012, upon remand by the Supreme Court by Per Curiam Order dated September 18, 2012, and after status conference on September 19, 2012, it is **ORDERED** and **DECREED** as follows:

1. **Hearing.** Hearing on remand shall begin at 10:00 a.m. on Tuesday, September 25, 2012, in Courtroom 3001, third floor, Pennsylvania Judicial Center, 601 Commonwealth Avenue, Harrisburg, Pennsylvania. Petitioners shall arrange for a court reporter to be present throughout the hearing. The hearing shall continue until approximately 5:00 p.m. that day, and if necessary, shall

recommence on Thursday, September 27, 2012 at 10:00 a.m., and continue until concluded.

2. **Briefs.** Pre-hearing briefs shall be filed and served by noon on Monday, September 24, 2012. The briefs shall contain argument pertinent to the Supreme Court's directive to "make a present assessment of the actual availability of the alternate identification cards on a developed record in light of the experience since the time the cards became available." In addition, the pre-hearing briefs shall contain other information required by Pa. R.C.P. No. 212.2, and shall include as an attachment a signed report from any proposed expert witness consistent with the substantive requirements of Pa. R.C.P. No. 4003.5 The parties may be subject to consequences for failure to comply with those Rules.

Post-hearing briefs may be filed within 24 hours of the close of the record.
