Program Development

- Designed and implemented substantial changes to externship program, including introducing an innovative instructional model to increase student engagement and broaden the curriculum to include topics such as combatting bias, cultural competency, professional identity development, and authentic leadership
- Implemented data-driven approach to revamping program

- Updated external-facing website language to reflect current program; included language placing compliance and D.C. externships under greater externship umbrella
- Provide instructors of all externship courses access to program documents and supporting materials

- Created and implemented new site application process designed to further program goals
- Developed and implemented a policy and tracking documents related to site visits
- Increased training for sites, including creating and distributing the program's first-ever supervisor manual and a planned half-day CLE scheduled for July 2023
